The goal of the PC is to create a seamless continuum of care to address the needs of the infected and affected in our Targeted Grant Area (TGA). The major objective is to ensure access to core medical services. PC duties include :



- 1) Establishing priorities for allocation of funds
- 2) Developing a Comprehensive Plan

3) Assessing the Administrative Mechanism

4) Participating in the Statewide Coordinated Statement of Need



5) Obtaining input on Community Needs & Priorities

6) Establishing & Monitoring Compliance with Operating Procedures
